AND HAVE THE NEWLY REQUIRED STAT DEC COMPLETED AND SIGNED BY A JUSTICE OF THE PEACE BEFORE THE LOGBOOK CAN BE PROCESSED. THIS IS IN COMPLIANCE WITH THE NEW CODE OF PRACTICE WHICH BECAME EFFECTIVE AS OF 1<sup>ST</sup> JULY 2012.

IF LOG BOOKS HAVE HAD 3 MEMBERSHIP YEARS WRITTEN AND STAMPED THEN VEHICLE NEEDS TO BE INSPECTED BEFORE NEW LOGBOOK CAN BE PROCESSED.

BEWARE CURRENT LOGBOOKS EXPIRE ON 30<sup>TH</sup> JUNE 2013 AND CAR CAN NO LONGER BE LEGALLY DRIVEN IF INSPECTION NEEDED AFTER THIS DATE.
